Coverage: Any part of the transfer case which fails because of defective parts or factory workmanship during the period of warranty may be exchanged for a remanufactured parts through Universal Manufacturing Company. This coverage is for the parts only and does not cover labor or transportation charges. Failed parts must be returned to receive warranty credit.

NOT Reimbursable: Consequential expenses, including but not limited to commercial loss, lodging, meals, phone calls, storage, vehicle rental, towing, etc are not reimbursable.

Coverage may be denied if failure is not due to defective workmanship or materials. Not to be limiting, damage caused to the transfer case that is the result of misuse of the vehicle caused by negligence, overloading, racing, driving over curbs, and from motor vehicle accidents, is not covered under the warranty and will void the warranty and coverage will be denied.
